What Size Sign To Use

The size of the signage is really dependent on how the person approached the area that is being recorded. For example, an A4 Sign is suggested for positioning at 'head height' so that passing individuals can be made aware of a scheme. Where it is likely that passing drivers need to be kept informed of the operation of a scheme an A3 sign is suggested.
